# Impact of the Monte Giarolo Wind Farm on the Sahaja Yoga Community

### Introduction

Numerous statements have been submitted to the Ministry regarding the environmental, visual, and economic impacts of the proposed "Monte Giarolo" Wind Farm project. However, this document highlights an aspect that has been seriously overlooked so far: the impact of the wind farm on the Sahaja Yoga community, which has its global centre in Val Borbera.

## **Project Overview**

The "Monte Giarolo" wind farm was presented in 2023 to the Ministry of the Environment and Energy Security by the company 15 più Energia S.r.l. to obtain a Single Environmental Permit (PUA). The project involves the installation of a wind farm consisting of 20 wind turbines, each with a total height of 209 metres (including a 128-metre tower and three blades approximately 80 metres each) and an individual power output of 6.2 MW.

The layout of the plant includes, on the western ridge, the installation of four turbines between Monte Giarolo and Passo di Brusamonica, one near Monte Panà, and three along the secondary ridge extending from Monte Cosfrone towards Val Borbera. On the eastern ridge, twelve turbines will be placed along the ridge between Monte Chiappo and Monte Boglelio. To ensure the transportation of components to the construction site, a 23 km long and 6-7 metres wide access road will be built, allowing access to the installation sites. The construction site will involve moving approximately 580,000 cubic metres of soil, part of which will be reused on-site, while the remaining material will be transferred to designated areas.

The electricity generated by the wind turbines will be transmitted via underground cables along Provincial Road 140 to a transformation station in Vendersi. From this station, a 21 km high-voltage power line will connect the plant to the national grid at Vignole Borbera.

# The Sahaja Yoga Community in Val Borbera

Sahaja Yoga is an international spiritual movement founded by Shri Mataji Nirmala Devi in 1970. Shri Mataji is considered one of the most significant spiritual figures of the 20th century (here is a list of awards and recognitions). During her childhood, she attended Gandhi's ashram, who affectionately called her "Nepali" due to her Nepalese features. As a teenager and university student, Shri Mataji actively participated in the Indian independence movement. From 1970 onwards, she dedicated her life to humanity, spreading Sahaja Yoga meditation, a method she developed to foster inner awakening through self-realisation (Shri Mataji Nirmala Devi, 2024).

In her numerous public talks, Shri Mataji emphasized the spiritual value of nature, describing it as a Mother who gives and sustains life, a living entity to be respected and venerated, in Sanskrit, 'Shri Bhoomi Devi', the Goddess of Earth. She also encouraged craftsmanship and handmade products (Shri Mataji, 1990). Therefore, her followers today maintain a sacred relationship with the land.

Shri Mataji recognised the great spiritual value of Val Borbera and believed that some of its mountains had "the same vibrations (spiritual energy) as those found in the Himalayas". In the early 1990s, Shri Mataji and the Sahaja Yoga community established their international centre within Palazzo Doria in Cabella Ligure. Since then, Cabella Ligure has become the global centre for the movement's practitioners, some of whom are now permanently residing in Val Borbera.

The Sahaja Yoga community organizes many global meditation gatherings and cultural events in Albera and Cabella Ligure. These events include concerts, festivals, and conferences, attracting thousands of people from around the world each year. The community owns or manages several properties in the municipalities of Cantalupo, Albera, and Cabella Ligure, including some accommodation facilities, a large meditation centre (hangar)mand various real estate assets, including Palazzo Doria, which houses the Shri Mataji Nirmala Devi World Foundation. Since its establishment, the Sahaja Yoga community has been a significant driver for the social and economic development of the valley (see Barbera et al., 2015), thanks to the thousands of devotees who visit Val Borbera every year, the settlement of new residents, and the management of small businesses such as the Hotel Posta (the only existing hotel in Cabella Ligure) and the numerous cultural activities.

## Impact on the Sahaja Yoga Community

The construction of the wind farm infringes on the religious sentiments and rights of the Sahaja Yoga community, which regards the Val Borbera area, and particularly Palazzo Doria in Cabella Ligure (see Figure 1), as a sacred place. This palace was the residence of Shri Mataji and, for those who practise Sahaja Yoga, is considered a place of pilgrimage, "the home of our spiritual mother in Italy" (more information about the history of Palazzo Doria for the Sahaja Yoga community <a href="https://example.com/here">here</a>).

The project's realisation would deny the community the right to continue using their places of worship as they have used them for the past three decades. This contradicts the United Nations Declaration on the Elimination of All Forms of Intolerance and Discrimination Based on Religion or Belief (1981), Article 6: "In accordance with article 1 of the present Declaration, the rights and freedoms set forth in article 1 include, inter alia, the following rights: (a) The right to worship or assemble in connection with a religion or belief, and to establish and maintain places for these purposes."

The installation of turbines over 200 metres high on the mountains behind Palazzo Doria would alter the iconic landscape of the main place of worship for a community that has thousands of devotees worldwide. Those who practise Sahaja Yoga perceive the mountains surrounding Palazzo Doria as a distinctive element of their place of worship and a characteristic of the landscape they enjoy for their spiritual practices.

Therefore, any modification of the landscape or intervention that alters the integrity of these places can be considered a violation of the rights of Sahaja Yoga practitioners. The construction of the wind farm would compromise the sacred and symbolic environment that the followers use for their spiritual practices, going against international law on the right to manifest one's religion in a place considered sacred.

In summary, this installation would undermine the symbolic and emotional value that the landscape around Cabella and Albera Ligure represents for the followers of Shri Mataji Nirmala Devi, who chose Italy and Val Borbera as her international centre, receiving honorary citizenship in 2006 and tirelessly promoting the revival of the area from both a social and economic standpoint.

The reasons driving the Sahaja Yoga community to oppose the wind farm should not be confused with NIMBYism ("Not in My Back Yard"). The Sahaja Yoga community is fully supportive of the transition to renewable energy, to the point of promoting an initiative to establish a renewable energy community (CER) in collaboration with various municipal administrations in Val Borbera (Barison, 2024). Moreover, its founder, Shri Mataji, had already expressed her interest and support for renewable energy sources in the early 1980s (Shri Mataji, 1983).

The Sahaja Yoga community opposes the proposed wind farm because, in addition to not respecting their rights, it also fails to align with the fundamental principles of a just transition as outlined by the European Union (Verdolini et al., 2024). These principles are based on the concept of energy justice (University of Sussex, 2023), which calls for a fair distribution of the benefits and costs associated with the energy transition, transparency and inclusiveness in decision-making processes, and the recognition of historical diversities and inequalities, especially of the most marginalised and vulnerable communities.

The proposed plant does not distribute its benefits and costs equitably between rural and urban areas. Furthermore, active citizen participation from the early design stages has not been ensured, thus excluding important stakeholders from decision-making processes. The proposal does not even recognise the rights and vulnerabilities of the territory, which is considerably more disadvantaged than others due to increasing depopulation and the

reduction of public services. Therefore, from a perspective strictly linked to the justice of the energy transition, the project does not respect fundamental principles of fairness ignoring the importance of places that are imbued with deeply rooted symbolic, emotional, and relational elements in the spiritual life of the Sahaja Yoga community.

In addition to these considerations, the potential economic repercussions deserve particular attention. The installation of the wind farm not only violates the rights and sentiments of the Sahaja Yoga community but also poses a significant economic threat. This installation could reduce tourism flows, including those related to the Sahaja Yoga community. Religious tourism attracts thousands of visitors each year and has contributed to the settlement of an increasing number of families in the valley. Tourists and new families provide significant support to the local economy, shopping in stores, frequenting cafes and restaurants, and using public services that would otherwise be at risk of closure. In this way, they not only support the economy but also strengthen the social fabric of the valley, ensuring its vitality and sustainability over time.
