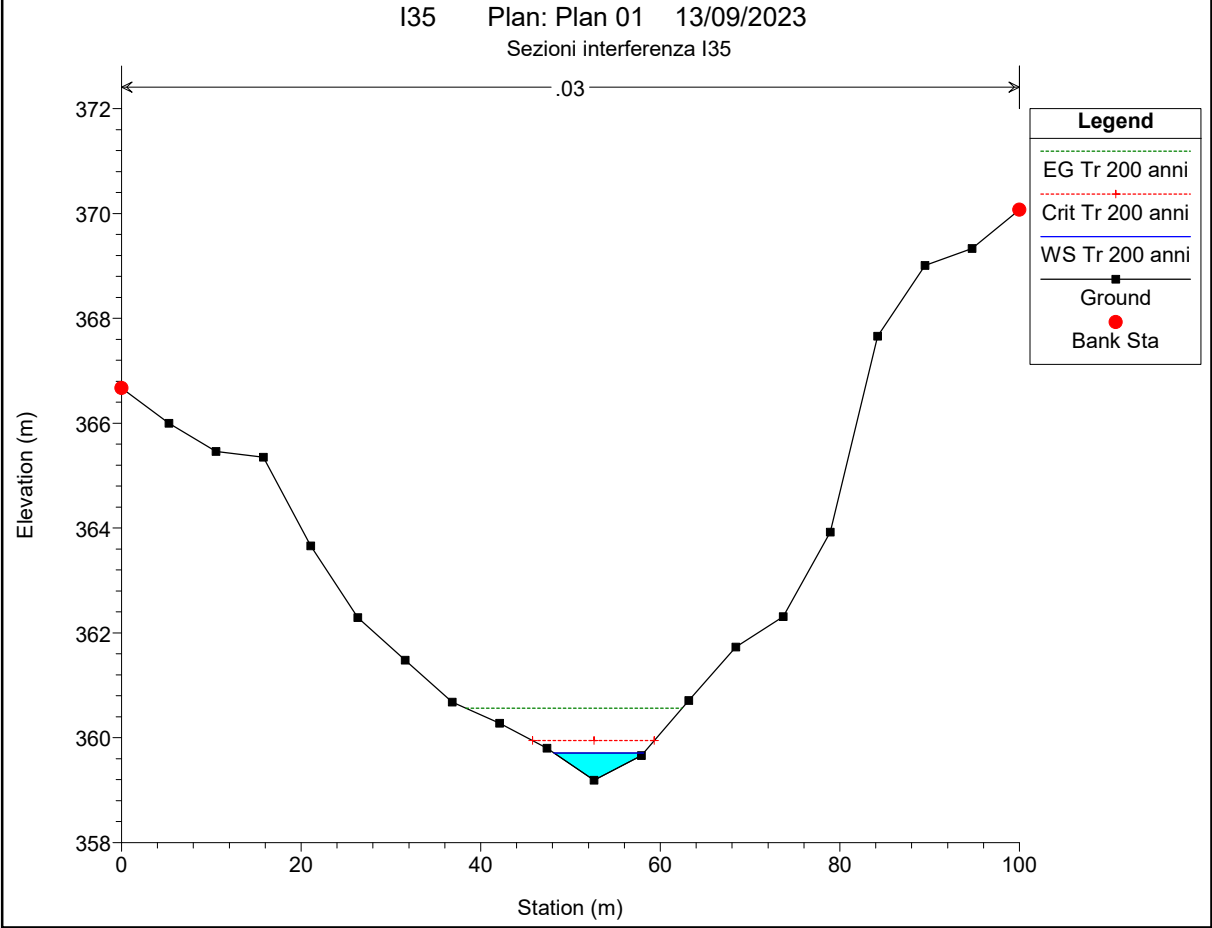
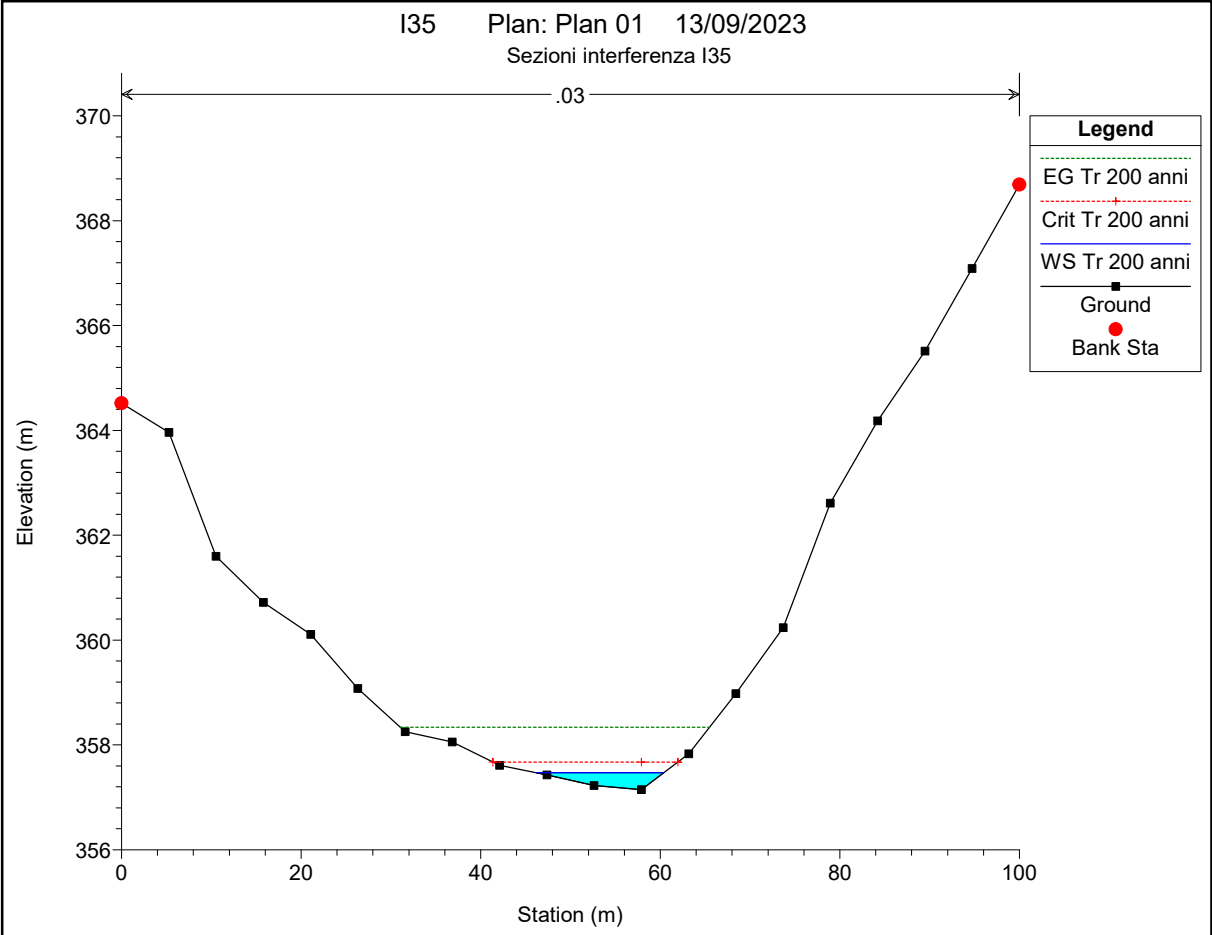


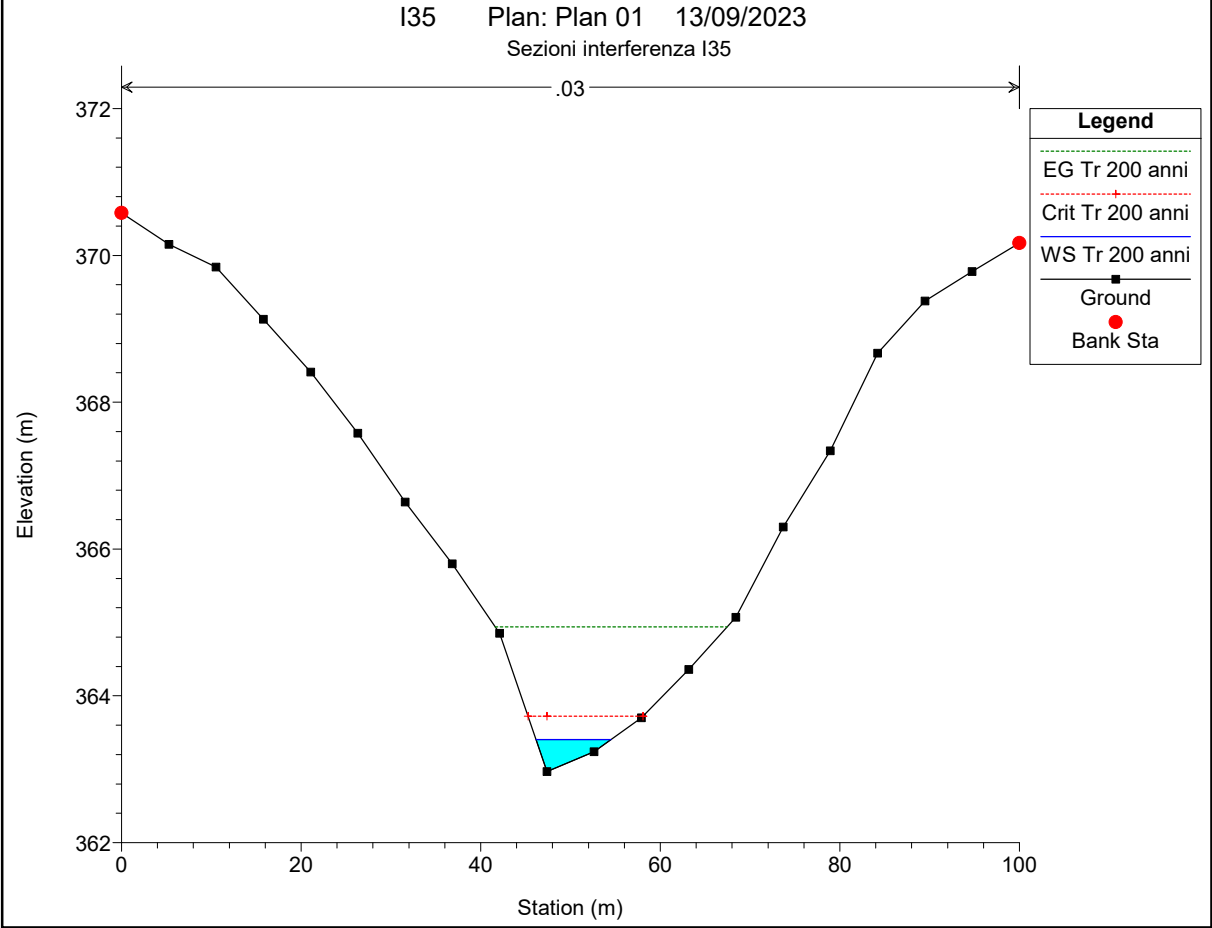
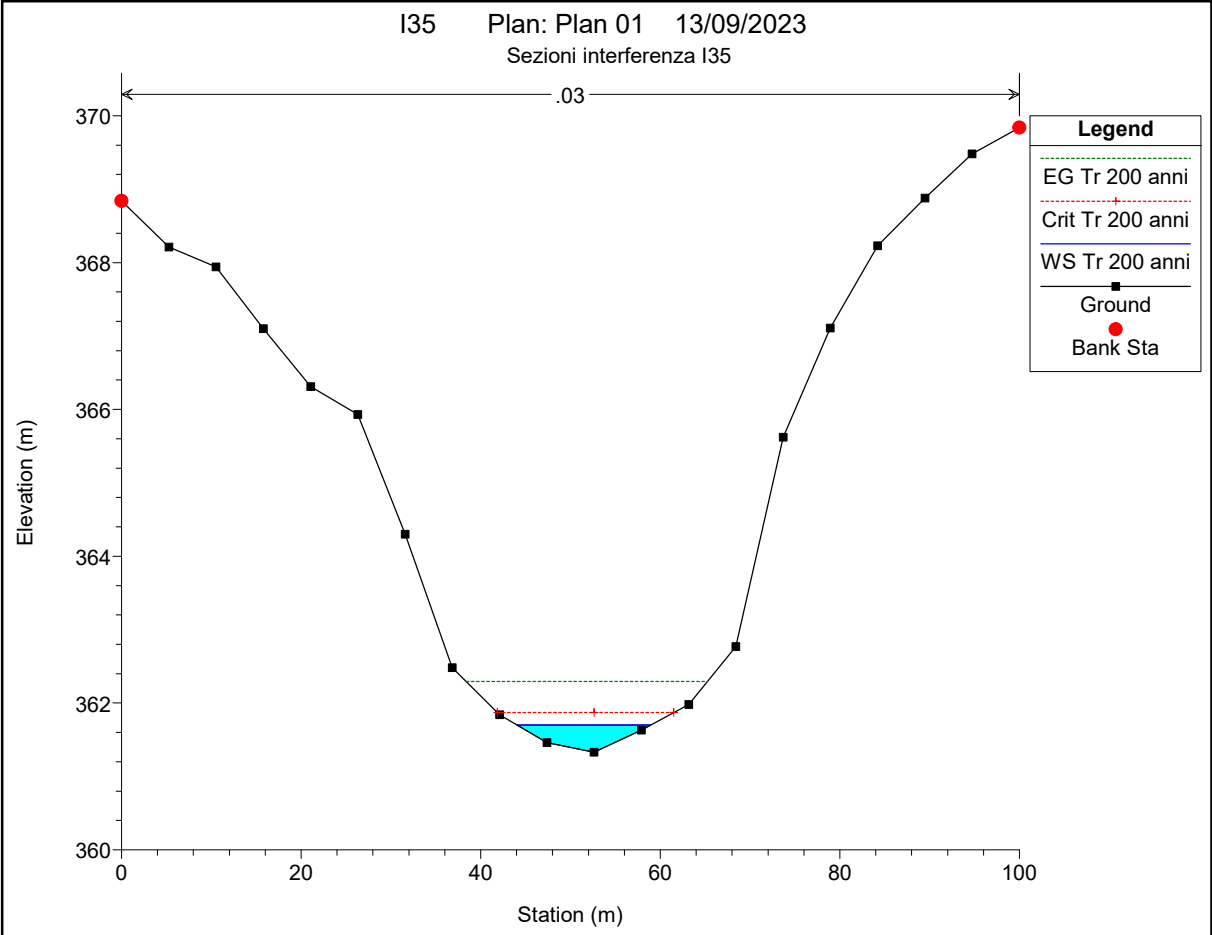


I34 Plan: Plan 01 13/09/2023

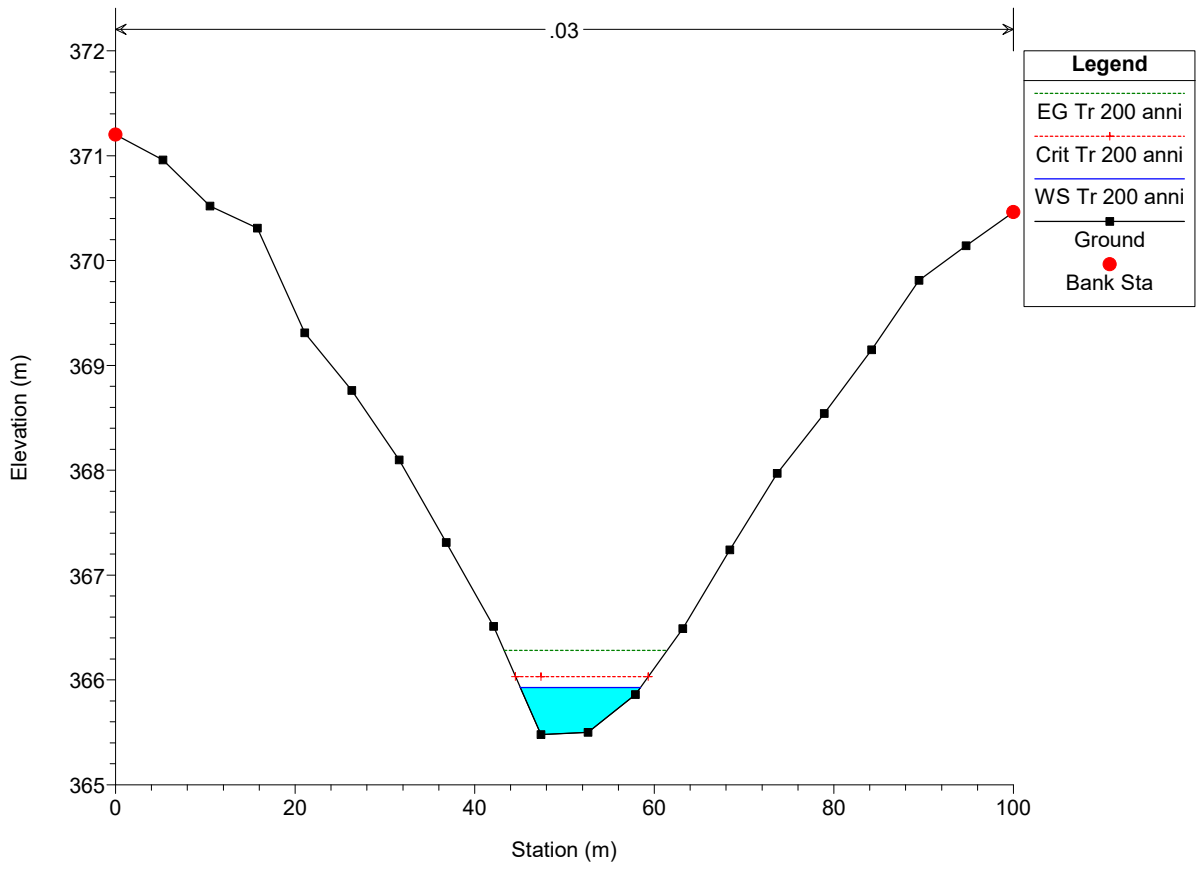
